Ordinary Meeting

Minutes

1. Welcome and apologies for absence

Colin Christison welcomed everyone to the ordinary May meeting. Apologies for absence were received from Tom Bonallo, Cllr Alison Dickie, Dora and Nino Lola-Luz, Carol McHugh, Jo Scott, and Colin Symes.

2. Police Report

No officer present.

3. Minutes of meeting held on 3 April 2018, and matters arising

Agreed; proposed by Jan Fraser and seconded by Hilary McDowell. There were no matters arising.

4. Chair's Report

4.1 Spotlight Cinema

It was understood that a planning application had been submitted for some amendments to the original plans. More information will become available in due course.

4.2 Holyrood Distillery

Work will start on the site (the former Engine Shed) in early June. Before and after tours of the building will take place in May, for a small charge which will be donated to a local charity.

4.3 General Data Protection Regulation

The membership application form had been redesigned to allow for the requirements of the above forthcoming legislation, and consent will be sought from all the people on the group mailing list so that they may continue to receive minutes and other items.

5. Treasurer's Report

Hilary said that the bank balance was £583.01, after paying for charges connected with the planning application for the two murals.

6. Planning & Licensing matters

- 6.1 Tables and Chairs application for SOUQ, 57-59 South Clerk Street, Edinburgh, EH8 9PP objection lodged to the 10pm application, and we queried that they had been given a licence in the first place.
- 6.2 18/01483/FUL Demolition of existing extension to form new 3 storey extension to Life Church building to provide additional space (meeting rooms, cafe, ancillary space). Change of use application to provide 3 no. studio apartments on the top floor of the new extension at 2A Davie Street, Edinburgh, EH8 9EB. It was agreed to object on grounds of overdevelopment of the site and the inappropriateness of the materials.
- 6.3 18/01623/LBC (internal works and external signage) and 18/01664/ADV (illuminated fascia and projecting sign) at public house at 74-78 South Clerk Street. Retrospective applications which compares the previous Clerk's Bar with what they say is proposed, although the work was done months ago. It was agreed to object on grounds of garishness and failure to comply with guidelines for businesses.
- 6.4 The Licensing Board workshop on overprovision on 2 May will be attended by Hilary McDowell.

7. Environmental matters

7.1 Nicolson Square 1 – this information was e-mailed to those on the SA's group list in April.

Working Together to Improve Nicolson Square

- 9.2 It was understood that the former Lismore Rugby Club on Pleasance, premises owned by the Council, might be occupied soon by a social café.
- 9.3 Bob Hodgart mentioned a meeting to take place at the Central Hall on 27 May about the India Building planning exercise and what can be learned for the future.
